- ✓ All fee is payable through demand draft favoring "Unison School of Law" payable at Dehradun.
- ✓ **Fee once paid is neither refundable nor adjustable under any circumstance whatsoever.**
- ✓ **Caution money is refundable only when:**

- ✓ The Scholarship mentioned in terms of percentage shall be calculated on the basis of tuition fee only.

- ✓ The Scholarships will be offered on a percentage of the total seats in the course, and the claim to the same shall be considered only at the time of admission.
